Please read these instructions before completing the form. 請於填寫表格前先閱讀以下說明。

Regulations based on Foreign Account Tax Compliance Act ("FATCA") and Organisation for Economic Co-operation and Development ("OECD") Common Reporting Standard ("CRS") require financial institutions to collect and report certain required information based on an individual account holder's tax residency status.

根據"外國帳戶稅收遵從法"(「FATCA」)和經濟合作暨發展組織(「OECD」)共同申報準則(「CRS」) 之規定,要求金融機構按照帳戶持有人的納稅居住地收集及匯報若干所需資料。

Each jurisdiction has its own rules for defining tax residence. In general, your tax residence is the country in which you live. Special circumstances (such as studying abroad, working overseas, or extended travel) may cause you to be resident elsewhere or resident in more than one country at the same time (multiple tax residencies). The country/countries in which you pay income tax are likely to be your country/countries of tax residence.
